This was despite a setback of a fire at our Ilseng plant in Norway. In line with our strategic vision, our Group resumed its path of growth. Our turnover was 56.1 million euros and it grew by 8.7% compared to the previous year.

Year 2017:

Highlights

Among our subsidiaries, Exsane Oy succeeded remarkably well in adopting its new service business strategy. The strategic shift from subcontracting to main contracting resulted in a significant growth in turnover.

PrimaTimber's impregnated timber business continued to improve efficiency throughout all operating chains. As a result, the higher quality of operations and products generated operational volume growth. PrimaTimber has certainly secured its position across Finland and is now developing its exports.

The core of our pole business operated by ScanPole lies in the UK market. With good service and premier quality products, as well as with efficient logistics, we have sustained our profitability and market shares.

In administration, we focused on the future. By developing Enterprise Resource Planning (ERP) and IT systems we paved the way to future growth. In addition to nominating new members to our Group Management Board, we strengthened our support functions.

In product development, we focused on research on wood preservation and treatment methods, as well as on developing new solutions for line inspections.

Year 2018:

Changing markets

We expect to see a new type of market situation in 2018. Sawn wood markets, both in Finland and abroad, are thriving, which tightens the competition in this market segment. PrimaTimber aims for a strong position in Finland, but also seeks new opportunities in exports.

In our service business we aim to secure profitable growth in the domestic market by strengthening project organization and the systems supporting it, by digitalizing some key functions.

In relation to our pole business, while the unsettled political situation in the Arab countries continues, we will seek operational growth mainly in the Scandinavian and UK markets. Our many years of experience and strong partnerships will assure profitability and steady volume growth.

Our family business values and committed employees have been our key for success from year to year. Our organizational structure is now working smoothly, and next we will focus on the systems supporting the business. After 2018, our organization will be in a winning position, and I look forward to working with colleagues throughout the Group to build future growth and success.

ScanPole is one of the leading pole producers in Europe. We deliver high-quality poles from Scandinavian forests to power networks and telecommunication utilities throughout the world.

Year 2017:

Global operations continued steadily

The Group's pole deliveries reached the total of 37 MEUR and we had customers in 14 countries. During the year, we produced over 70.000 m³ of impregnated poles. In addition, we delivered nearly 30.000 m³ of untreated poles to end-users.

In Norway, the year was challenging for us due to a fire at our Ilseng plant. Despite the setback, we were able to serve our customers in Norway and Sweden and we reached a positive result. We increased both sales volumes and profitability in the Swedish market, and our sales grew by 14% compared to the previous year.

In the UK, at our Newport plant, we updated our production practices and improved pole storage techniques.

Year 2018:

Development continues

We expect to follow the same path of development in all domestic markets in 2018 as in 2017. Copper oil and next generation impregnation substances will be in demand as alternatives to creosote, and we are ready to provide them.

Pressure treated wood with famous Nordic durability

PrimaTimber produces and delivers premier quality impregnated timber, building materials for outdoor uses and a wide range of components. Our customer base consists of leading retailers, wholesale chains and wood product manufacturers. Our main market areas are Finland, western Europe and Asia.

Year 2017:

Steady volume growth

The turnover of PrimaTimber Oy was a total of 11.9 MEUR, being 6.2 % higher than the previous year. Domestic sales were dominant while the share of exports was less significant. Investing in quality, both in operations and products, continued throughout the operating chain. We also built a new storage hall at the Joensuu plant in 2017.

The prices of raw material remained at a moderately stable level during the first half of the year. Later in the year sawn timber exports picked up and consequently raw material prices started to rise.

Year 2018:

Sawn products markets in change

High demand for sawn wood will have an impact on acquiring raw material and on the prices of finished products in 2018. We will seek growth in exports and continue to provide high-quality products and unbeatable customer service.



Comprehensive utility networks and reliable service

Exsane Oy builds, inspects and maintains electricity, streetlight and optical fibre networks. Our service range also includes planning and forestry operations.

Year 2017:

From subcontracting to main contracting

The turnover of Exsane Oy in 2017 was 7.2 MEUR, being 138 % higher than the previous year. The increase was due to positive development in building projects and the forestry business.

Our project business was boosted by direct contracts with network companies and in forestry as well as by subcontracting. The Finnish Electricity Market Act setting obligations for electricity network providers came into force in 2013. Consequently, as electricity companies are required to develop secured delivery of electricity and underground cabling, they pay increasing attention to the maintenance of networks. Today, forestry operations are often carried out with an overall responsibility.

Year 2018:

Outsourcing gives opportunities for growth

Outsourcing is a growing trend in the electricity business and provides opportunities for Exsane Oy. There are promising prospects for growth in the domestic market, and projects applying competitive bidding are more extensive than before.

Financial year

The Group's total turnover in 2017 was 56.1 MEUR, being 8.7% higher than the previous year.


Investments

The Group's investments in 2017 reached the total of two million euros.

- ScanPole Oy invested in the modernization of machinery. The total sum of investments was 300.000 EUR.
- BBH Ltd invested a total sum of 400.000 EUR.
- PrimaTimber Oy invested in e.g. a storage hall.
 The total amount of the investments was 550.000 EUR.
- Exsane Oy invested 150.000 EUR mainly in vehicles.

An unfortunate fire damaged ScanPole As impregnation plant severely in January 2017. Consequently, ScanPole As property for approximately 400.000 EUR was written down. Insurance compensation was received for a total of 1.17 MEUR.

The building of a new impregnation plant started in May, and the invested sum for the new plant was 600.000 EUR.
